**Ten year Reviews**

**Committee discussion re Five Year Process:**

- + helpful dialogue between reviewers and centers
- + helpful in preparation for the Ten Year Review
- + annual reviewers' involvement in Five and Ten Year Reviews provides continuity
  
- process seems to focus on programs with residencies; other creative programs don't get similar attention
- need for clarity as to which Standards are used for self study
- continued need for summary of standards changes from Standards Commission -need for consistency in review guidelines

**Center changes:**

- St. Mary's, Duluth, satellite of City of Lakes Transitional Care Center, for the Summer 2001 program
- Wausau Hospital, Wausau: CPE Ministry Program is no longer satellite, new Supervisor, William Tallevast (note: CPE Ministry Program, Gerri Krautkramer, Supervisor, is now a satellite of Lutheran Homes of Oshkosh)
- North Dakota State Hospital vacant, John Serkland has retired
- Vista Health vacant, George Franke has retired
- Rochester Methodist is now named "Mayo Clinic CPE"
