At the fall 2000 meeting in Nashville, 22 candidates met the commission and 11 were granted Associate Supervisor status; 19 associates met and 15 were granted ACPE Supervisor status. Three associates met the committee at the region's spring business meeting in Madison last year, and one was granted CPE Supervisor status.
